**General Comments**

Facility receives food at noon from Anderson Middle School and follows Time as a Public Health Control (TPHC) guidelines. Any unused food is discarded after 4 hours. Temperature and transport logs are maintained. Any deviation from foods approved by the TPHC guidelines must be pre-approved by Florida Department of Health in Martin County (FDOH). A copy of the TPHC form must be available for review at each inspection to ensure that only food on this form is being served to students.

Kernel corn and nacho sauce 123 degrees F at arrival. 175 and 170 degrees F leaving Anderson according to log. (Suggest maintaining higher heat at Anderson to account for loss of temperature during transport.)

Carton chocolate milk (exp. 2/16) arrived at 39 degrees F.

Tossed salad 41 degrees F.
